Board and Train Program Agreement

This agreement is made and entered into on the date above by and between the above listed owner and Alpha Dogs Training Center, Inc., dba Colorado Dog University (CDU), who both do state and agree to each of the following provisions:

(1) The owner desires that the owner's dog undergo a board and train program for a length of stay as stated above, and the owner desires that said training be conducted by CDU through its agents or employees. The commands that will be taught/behaviors addressed are as follows: _____

(2) Upon completion of the board and train program, the owner will be taught how to properly maintain the dog's new skills and behaviors. One private lesson is provided per week of stay. The first lesson will be on the day of completion of the training program and will take place at CDU, the second, third or fourth private training lessons will occur either at CDU, in the owner's home or some agreed upon location

and must take place within four weeks of completion of the program. In home lessons are given only if the client lives within 20 miles distance from CDU. If the distance is greater and owner desires an in home lesson a trip fee will be assessed and must be agreed upon prior to scheduling. Lessons are not timed but typically last between one and two hours. Unused lessons are not refundable.

(3) The owner understands and agrees that without 100% cooperation with the trainer, which includes consistent training practice as per trainer instruction, the dog may not maintain the training it has received. The owner further understands that his or her ability to understand the information provided in the lessons and effectively apply it to the dog directly correlates to how the dog responds to the owner. The owner understands that the owner is ultimately responsible for the dog's final response to them. Owner is solely responsible for the dog's behavior after the training program is completed.

(4) The owner understands and agrees that the owner's dog will be treated by a veterinarian if deemed necessary and all veterinary charges are the sole responsibility of the owner and payable upon pick up of owner's dog. In the event the above stated animal dies while at CDU, the animal will be kept at the Animal Clinic of Parker at 19557 East Parker Square Drive, Parker, CO 80138.

(5) Owner understands and agrees that the above stated animal may be transported for training purposes and agrees to hold CDU and its agents harmless for any injuries or loss that may result from said transport.

(6) In full recognition of the above, owner understands and agrees that the program fee of \$_____ is a reflection of time expended by CDU and not a reflection of goal attainment during said training. \$_____ is to be paid on ___/___/___, when the dog is dropped off for the training program and the remaining fee of \$_____ is due on ___/___/___, when the dog is picked up at the completion of the program.

Liability Release: I, _____, as the legal owner of the dog being trained, have carefully read and fully understand this agreement, do hereby waive and release CDU from any and all liability of any nature. This includes any injury, death, sickness or damage my pet may suffer or cause during or after any training program. I also agree to indemnify and hold harmless CDU from any and all claims due to damage the dog may cause to any family members or any third parties during or after training. I agree that I am solely responsible for my dog's behavior after the completion of the training program.

If any provision of this agreement is declared invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall be enforced to the full extent permitted by law. Any disputes will take place in the courts of Elbert County, Colorado.

This agreement is the full and only agreement between the parties and the terms and conditions cannot be modified unless in writing by both parties.
